

# Roads Amendment (Penalty Notice Offences) Regulation 2019

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Roads Act 1993*.

#### **Explanatory note**

The object of this Regulation is to increase the amount of penalty payable for offences under the *Roads Regulation 2018* for which penalty notices may be issued. The increases are generally in line with movements in the Consumer Price Index.

This Regulation is made under the *Roads Act 1993*, including sections 243 and 264 (the general regulation-making power).

#### 2 Commencement
