Explanatory note

The objects of this Regulation are to amend the *Motor Dealers and Repairers Amendment (Tradesperson's Certificates) Regulation 2020* to—

- (a) clarify the descriptions of certain classes of repair work, and
- (b) prescribe a qualification for glazing work.

This Regulation is made under the *Motor Dealers and Repairers Act 2013*, including sections 6(2) (the definition of *repair work*), 26(2) and 186 (the general regulation-making power).

1 Name of Regulation

This Regulation is the *Motor Dealers and Repairers Amendment (Tradesperson's Certificates) Amendment Regulation 2020.*

[1] Clause 2 Commencement

Insert ", except as provided by subclause (2)," after "1 September 2020".

[2] Clause 2(2)

Insert at the end of the clause—

- (2) The following provisions commence on 1 November 2021—
 - (a) Schedule 1[1] to the extent that it inserts paragraphs (c1) and (c3) into clause 34,
 - (b) Schedule 1[4] to the extent that it inserts paragraphs (c1) and (c3) into clause 36.

[3] Schedule 1 Amendment of Motor Dealers and Repairers Regulation 2014

Omit proposed clause 34(c2) from Schedule 1[1]. Insert instead—

(c2) **exhaust repair work**—being the work carried out by persons who fabricate, modify, service or repair the exhaust systems of motor vehicles, but does not include work on the chassis of motor vehicles,

[4] Schedule 1[1]

Omit ", but does not include work carried out on hybrid or electrically powered motor vehicles" from proposed clause 34(c3).

[5] Schedule 1[2]

Omit "balance or" from proposed clause 34(h2)(ii).

[6] Schedule 1[4]

Omit proposed clause 36(1)(c3). Insert instead—

- (c3) for glazing work—
 - (i) Certificate II in Automotive Body Repair Technology, including the Automotive Glazing specialist elective units from the Automotive Industry Retail, Service and Repair Training Package, or
 - (ii) Certificate III in Automotive Glazing Technology, being part of the Automotive Industry Retail, Service and Repair Training Package,
