Explanatory note

The object of this regulation is to amend the *Mental Health Regulation 2019* to update cross-references to Victorian legislation.

This regulation is made under the *Mental Health Act 2007*, including sections 172(1) and (2), 179(4)(a), 182(2)(a), 187(e) and 196, the general regulation-making power.

1 Name of regulation

This regulation is the Mental Health Amendment Regulation 2024.

2 Commencement

This regulation commences on the day on which it is published on the NSW legislation website.

Schedule 1 Amendment of Mental Health Regulation 2019

[1] Clause 19 Definitions

Omit "section 150 of the *Mental Health Act 2014* of Victoria" from clause 19(1), definition of *authorised psychiatrist*.

Insert instead "the Mental Health and Wellbeing Act 2022 of Victoria, section 328".

- [2] Clause 19(1), definition of "relevant corresponding law", paragraph (a) Omit "Mental Health Act 2014". Insert instead "Mental Health and Wellbeing Act 2022".
- [3] Clause 19(1), definition of "Victorian mental health facility" Omit "Mental Health Act 2014". Insert instead "Mental Health and Wellbeing Act 2022".

[4] Clause 20 Corresponding laws

Omit "*Mental Health Act 2014*" from clause 20(a). Insert instead "*Mental Health and Wellbeing Act 2022*".

[5] Clause 22 Apprehension of patients and persons under interstate apprehension orders

Omit "*Mental Health Act 2014*" from clause 22(2)(b)(i). Insert instead "*Mental Health and Wellbeing Act 2022*".

 [6] Clause 26 Transfer of interstate persons to mental health facilities in this State Omit "under the *Mental Health Act 2014*" from clause 26(2). Insert instead "under the *Mental Health and Wellbeing Act 2022*".

[7] Clause 26(2)(b)

Omit "section 322 or 323 of the *Mental Health Act 2014* of Victoria". Insert instead "the *Mental Health and Wellbeing Act 2022* of Victoria, section 600 or 602".

[8] Clause 27 Victorian community treatment orders relating to New South Wales residents

Omit "section 45 or 55 of the *Mental Health Act 2014* of Victoria" from clause 27(1). Insert instead "the *Mental Health and Wellbeing Act 2022* of Victoria, section 180 or 192".

[9] Clause 27(2)

Omit "Mental Health Act 2014". Insert instead "Mental Health and Wellbeing Act 2022".
