An Act to amend an Act intituled “ *An Act for* COURT OF CLAIMS.  
“ *appointing and empowering Commissioners to*  
“ *hear and determine upon Claims to Grants of*  
“ *Lands under the Great Seal of the Colony of*  
“ *New South Wales.*” [18th July, 1834.]

**W**HEREAS it is expedient to amend a certain Act of His Excellency the Governor with the advice of the Legislative Council made in the fourth year of the reign of His present Majesty King William the Fourth intituled “ *An Act for appointing and empowering Commissioners to hear and determine upon Claims to Grants of Lands under the Great Seal of the Colony of New South Wales* ” Be it therefore enacted by His Excellency the Governor of New South Wales with the advice of the Legislative Council thereof That so much of the said recited Act as relates to the sum of money thereby authorized to be paid to the Commissioners for each and every final report by them made as therein mentioned and to the yearly salary of the Secretary of the said Commissioners and also to the fees thereby authorized to be paid to the said Secretary as specified in the Schedule thereunto annexed marked with the letter C shall be and the same is and are hereby repealed except as hereinafter provided and that from and after the passing of this Act the Commissioners appointed for hearing and determining upon Claims to Grants of Lands in pursuance of the said recited Act shall and may receive for their own use for each and every final report made by them in manner and form as in the said recited Act is directed upon any claim or claims to a grant of land in opposition to which some other claim or claims is or are filed and prosecuted to a final hearing and upon which respective claims the said Commissioners shall determine the sum of six pounds and for each and every final report made as aforesaid upon any such claim or claims in opposition to which no other claim or claims is or are filed and prosecuted as aforesaid the sum of two pounds and that the Secretary to the said Commissioners appointed as in the said recited Act is directed shall and may receive for his services a yearly salary of three hundred pounds which several sums shall be paid to the said Commissioners and Secretary respectively as in the said recited Act is mentioned and directed.

2. And be it further enacted That the several fees specified in the Schedule hereunto annexed marked with the letter A shall be paid for and in respect of all acts matters and things required to be done and completed under the said recited Act in lieu of the several fees specified in the Schedule thereunto annexed marked with letter C and shall be accounted for and appropriated in such and the like manner as in the said recited Act is mentioned and directed with respect to the fees specified in the Schedule annexed to the said recited Act.

3. Provided always and be it further enacted That the said Commissioners shall be entitled to receive the sum of six pounds for every final report actually made by them before the passing of this Act upon claims to grants of lands as in the said recited Act is directed anything herein contained to the contrary notwithstanding.
