WHEREAS an Act of the Governor and Council of New South Wales was passed in the second year of the reign of His late Majesty King William the Fourth intituled "An Act for regulating the constitution of Juries and for the Trial of Issues in certain cases in the Supreme Court of New South Wales" And whereas the said Act was by a certain other Act of the said Governor and Council passed in the fourth year of the reign of His said Majesty intituled "An Act to continue for a limited time an Act of the Governor and Council of New South Wales intituled 'An Act for regulating the constitution of Juries and for the Trial of Issues in certain cases in the Supreme Court of New South Wales' and to make further provision for Trial by Jury in criminal cases in the said Colony" continued until the thirtieth day of June one thousand eight hundred and thirty-five And whereas the said first recited Act was by a certain other Act of the said Governor and Council passed in the fifth year of the reign of His said Majesty intituled "An Act to continue for a limited time an Act of the Governor and Council of New South Wales intituled 'An Act for regulating the constitution of Juries and for the Trial of Issues in certain cases in the Supreme Court of New South Wales' and to make further provision for Trial by Jury" further continued until the thirtieth day of June one thousand eight hundred and thirty-six And whereas the said first recited Act was by a certain other Act of the said Governor and Council passed in the sixth year of the reign of His said Majesty intituled "An Act further to continue for a limited time an Act intituled 'An Act for regulating the constitution of Juries and for the Trial of Issues in certain cases in the Supreme Court of New South Wales' and to make further provision for Trial by Jury" further continued until the thirtieth day of June one thousand eight hundred and thirty-seven And whereas the said first recited Act was by a certain other Act of the said Governor and Council passed in the seventh year of the reign of His said Majesty intituled "An Act to further continue for a limited time an Act intituled 'An Act for regulating the constitution of Juries and for the Trial of Issues in certain cases in the Supreme Court of New South Wales'" further continued until the thirtieth day of June one thousand eight hundred and thirty-eight And whereas the said first recited Act as altered and amended by any or all of the Acts herein last recited was by a certain other Act of the said Governor and Council passed in the first year of the reign of Her present Majesty Queen Victoria intituled "An Act to further
