COURTS OF REQUESTS
FEES.

An Act to amend the Act of Council six Victoria number fifteen in respect of the Fees receivable in the Courts of Requests for the County of Cumberland. [11th August, 1853.]

Preamble. **W**HEREAS it is expedient to amend the Act of Council passed in the sixth year of the reign of Her present Majesty Queen Victoria numbered fifteen so far as it relates to the Fees of Office to be received in the Courts of Requests for the County of Cumberland Be it therefore enacted by His Excellency the Governor of New South Wales with the advice and consent of the Legislative Council thereof as follows ;—

Courts of Requests Fees.

1. So much of the said recited Act as empowers the said Governor with the assistance of the said Commissioner to make Rules and Regulations touching the Fees and sums of money to be taken by the several Officers of the said Courts of Requests shall be and the same is hereby repealed. Certain parts of sections 39 and 40 of 6 Vic. No. 15 repealed.

2. After the first day of October next the Fees payable in the said Courts on all Process issued therefrom shall be those mentioned in the Schedule hereunto annexed and no other Fees in respect of any Process or Proceeding therein shall be payable or shall be received by the Officers of the said Courts. Fees on Process.

3. All Fees received or receivable by any such Officer (the Fees properly due to and receivable by the Bailiffs of the said Courts as mileage levy and possession fees excepted) under and by virtue of this Act shall be paid to Her Majesty for the public uses of the Colony and in support of the Government thereof and shall be applied in such manner as may be from time to time directed by any Act of the Governor and Legislative Council. Fees of officers of Courts to be paid to Her Majesty.
