An Act to alter and amend an Act intituled
“*An Act for the making and upholding of the
Public Roads in the County of Cumberland and
for other purposes therein mentioned*” and to
divide the Windsor Road Trust into two
separate Trusts for Windsor and Richmond
respectively. [20th September, 1854.]

WHEREAS by an Act of the Governor and Council passed in the Preamble.
thirteenth year of Her present Majesty's reign intituled “*An* 13 Vic. No. 41.
“*Act for the making and upholding of the Public Roads in the County
of Cumberland and for other purposes therein mentioned*”
a certain Road Trust nominated the “Windsor Trust” was created
charged with the management and upholding of certain roads as
enumerated and specified in the Schedule to the said Act annexed
And whereas it is expedient to divide the said Windsor Road Trust
and to substitute in lieu thereof two Trusts to be called the Windsor
and Richmond Trusts respectively Be it therefore enacted by His
Excellency the Governor of New South Wales by and with the advice
and consent of the Legislative Council thereof as follows:—

1. So much of the said recited Act and the Schedule thereto so much of the
present Act repealed.
annexed as constitutes and specifies a separate Road Trust called
“The Windsor Trust” shall be and the same is hereby repealed
except as hereinafter provided.

2. From and after the passing of this Act in lieu of the said New Trusts created
in lieu of the
Windsor Trust.
“Windsor Trust” the several Trusts expressed in the Schedule to this
Act annexed shall be and the same are hereby constituted and appointed
And it shall be lawful for the Governor of the said Colony for the time Governor to appoint
Commissioners.
being to nominate and appoint by writing under his hand fit and proper
persons

Windsor Road Trust.

persons to be the Commissioners for the said respective Trusts hereby created in the same manner in all respects as he is empowered to do under the said recited Act in appointing Commissioners therefor and thercin.

Commissioners appointed under this Act to have the same rights powers and authorities as former Commissioners.

Not to affect any existing contracts.

Nothing in 2nd William IV. No. 12 section 24 to extend to this Act.

Moneys receivable under this Act to be applied to making upholding roads &c.

3. The Commissioners to be appointed as aforesaid under this Act shall have the same vested rights powers privileges and authorities and be subject to the same restrictions in all respects with reference to the Trusts to which they shall respectively be appointed as are conferred upon given and belong to the Commissioners already or to be appointed under or by virtue of the said recited Act. And the said recited Act shall be extended and applied in all respects so far as it can or may be to the respective Trusts hereby created in the same manner as if the said respective Trusts hereby created had originally been specified in the Schedule to the said recited Act annexed.

4. Provided that nothing herein contained shall be deemed or taken to affect annul or apply to any contract agreement matter or thing already made or done by the original Road Trust known as the "Windsor Trust" aforesaid but that all such contracts agreements matters and things shall be and the same are hereby declared to be transferred to and fully vested in the Commissioners to be appointed as aforesaid for the new Windsor and Richmond Trusts hereby created.

5. Nothing contained in the twenty-fourth section of the Act passed in the second year of the reign of His late Majesty King William the Fourth and numbered twelve with reference to the width of any street highway or turnpike road shall extend to any street highway or turnpike road which may be within the limits of any town situated within the boundaries of the Trusts hereby created.

6. All sums of money received under the provisions of this Act shall be paid to the Commissioners to be applied by them towards the making maintaining and upholding the roads within the said Trusts and other purposes relating thereto.

SCHEDULE REFERRED TO.

WINDSOR TRUST.

The Streets in Windsor through which the Mail passes.
The Road from Windsor to the Lock-up at Vinegar Hill 7½ miles
The Road from Windsor to Richmond 2½ miles.

RICHMOND TRUST.

The Streets in Richmond through which the Mail passes.
The Road from Windsor to Richmond 2½ miles.
The Road from Richmond by which the Mail passes to the north bank of the Hawkesbury River where the punt crosses that river 2 miles.
The Blacktown or Richmond Road from Richmond to the Eastern Creek 11 miles.
