An Act for granting Duties of Customs. [14th CUSTOMS DUTIES.
September, 1855.]

WHEREAS it is expedient to alter the Customs Duties of the Preamble.
Colony Be it therefore enacted by His Excellency the Governor
of New South Wales by and with the advice and consent of the
Legislative Council thereof as follows:—

1. The Acts of Council sixteenth Victoria number seven and Acts repealed 16
eighteenth Victoria number twenty-four are hereby repealed except Vic. No. 7 18 Vic.
in so far as such Acts or either of them may have operated to repeal No. 24.
any former enactment.

2. In lieu and instead of all Duties of Customs heretofore Duties levied.
levied upon goods wares and merchandise imported into the Colony of
New South Wales there shall be payable the several Duties of Customs
mentioned in the Schedule hereto and no others.

3. Provided that all goods imported for the supply of Her Remission of duties
Majesty's service shall be exempt from all duties and imposts of every on goods for Her
description whatsoever and that nothing in this Act contained shall be Majesty's service

4. It shall be lawful for the importer of any goods subject to Provisions as to
any duty of Customs to warehouse such goods upon the first entry warehousing goods
thereof under the laws in force for the warehousing of goods without in bond.
payment of duty upon such first entry and all goods warehoused before
the passing of this Act and which remain so warehoused shall be liable
on entry for home consumption to the duties hereby imposed.

5. There shall be allowed upon the exportation of refined sugar Drawbacks.
made in this Colony the amounts of drawback following that is to
say—

Upon *refined sugar* having been duly clarified and
thoroughly dried in the stove and being of an
uniform whiteness throughout at the rate of for
every hundredweight 6s. 8d.

Upon *refined sugar known as bastard sugar* at the
rate of for every hundredweight 5s. 0d.

Provided that such sugars respectively shall be shipped under the
care of the proper officer of Customs in order that the shipment
and exportation thereof may be duly certified on the debenture.

6. This Act shall be deemed to have come into operation on the Act to take effect
twelfth day of September in the present year. from 12th September.

7. And whereas it was deemed expedient to close the Custom Indemnity to Officers

day as a preliminary to the alteration of the said duties Be it enacted House.
that all Officers of Customs and all other persons concerned in closing
the Offices of the said Customs and in refusing to transact the ordinary
business thereof shall be and they are hereby indemnified freed and
discharged from and against all actions suits prosecutions and penal-
ties whatsoever for or on account of or connected with the closing of
the said Customs or the refusal to receive any moneys in payment of
duties on the said days on which the said Custom House was so closed
or the refusal to transact the ordinary business thereof and no such
action suit or prosecution shall be instituted by or against any person
whatever for any such closing or refusal as aforesaid.

8. Every person who shall on or before the passing of this Act have made or entered into any contract or agreement for the sale or delivery free of duty upon or at any time after such day of any article whereupon any additional duty shall be payable under the provisions of this Act shall be at liberty to add to the price contracted for so much money as will be equivalent to the additional duty which shall by reason of such provisions have been paid or made payable on such articles and shall be entitled by virtue of this Act to be paid the same accordingly by the purchaser of such article and to sue for and recover the same against such purchaser. Provided that it shall be at the option of such purchaser by notice in writing under his hand to be served on the other party to such contract within two months after the passing of this Act to declare the contract null and void and the same shall be null and void accordingly.
