

Act No. 9, 1910.

An Act to vest certain land in the Lords Commissioners of the Admiralty in trust for a recreation ground for the Royal Navy ; and for purposes consequent thereon or incidental thereto. [19th August, 1910.]

WHEREAS it is thought desirable that certain land situate at Rose Bay be vested in the Lords Commissioners of the Admiralty for a recreation ground for the Royal Navy : Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. This Act may be cited as the "Royal Navy Recreation Ground Act, 1910." Short title.

2. The land described in the Schedule to this Act is hereby transferred to and vested in the Commissioners for executing the office of Lord High Admiral for the time being, and their successors in office, in trust for a recreation ground for the Royal Navy, subject to the following conditions:—

- (a) All minerals in such land are reserved to the Crown, and such reservation shall have effect as if made in a Crown grant.
- (b) If such land ceases to be used exclusively for a recreation ground for the Royal Navy, it shall thereupon revert in His Majesty, free from all estates, interests, and trusts affecting the same, and be Crown land within the meaning and for the purposes of the Crown Lands Act of 1884, and any Act amending the same.

SCHEDULE.

COUNTY of Cumberland, parish of Alexandria, at Rose Bay, area 8 acres 2 rods 34 perches: Commencing on the north-western side of the New South Head Road at a point bearing south 61 degrees 12 minutes west 1 chain 35 $\frac{1}{10}$ links from its intersection with the south-western boundary of land held under ninety-nine years' lease by the executors of the late Elizabeth R. Bremer; and bounded thence by the said road, being lines bearing south 61 degrees 12 minutes west 2 chains 51 $\frac{1}{10}$ links; south 59 degrees 59 minutes west 2 chains 36 links; south 56 degrees 9 minutes west 4 chains 8 $\frac{7}{10}$ links; and south 53 degrees 14 minutes west 20 links; thence by a line bearing north 44 degrees 58 minutes 30 seconds west 10 chains 20 $\frac{1}{2}$ links; and thence by lines bearing north 55 degrees 26 minutes east 6 chains 45 $\frac{2}{5}$ links; north 75 degrees 38 minutes 30 seconds east 80 links; north 87 degrees 58 minutes east 70 links; south 80 degrees 59 minutes 30 seconds east 70 links; south 68 degrees 50 minutes east 70 links; south 53 degrees 13 minutes 30 seconds east 80 links; and south 48 degrees 42 minutes 30 seconds east 8 chains 30 $\frac{1}{10}$ links, to the point of commencement;—as shown on plan catalogued Ms. 2408 Sy.
