

SUPPLY ACT.**Act No. 21, 1956.**

Elizabeth II, An Act to apply certain sums out of the Consolidated Revenue Fund, the Government Railways Fund, the Road Transport and Traffic Fund, the Metropolitan Transport Trust General Fund, the Newcastle and District Transport Trust General Fund, the Sydney Harbour Trust Fund, and the Sydney Harbour Trust Renewals Fund, towards the services of the Year 1956–1957.

Preamble. **W**HEREAS we Your Majesty's most dutiful and loyal subjects, the Members of the Legislative Assembly of New South Wales in Parliament assembled, have resolved to grant to Your Majesty the sum of Thirty-two millions six hundred and twenty-two thousand eight hundred pounds, that is to say—

Out of the Consolidated Revenue Fund, the sum of Sixteen millions seven hundred and seventy-seven thousand pounds, being the sum required to defray the expenses of the various Departments and Services of the State during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven.

Out of the Government Railways Fund, the sum of Twelve millions four hundred and thirty-two thousand eight hundred pounds to defray the salaries, maintenance and working expenses and other expenses of the Department of Railways during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven.

Out of the Road Transport and Traffic Fund, the ^{No. 21, 1956.} ~~—~~ sum of Four hundred and sixty-eight thousand four hundred pounds to defray the salaries, maintenance and working expenses and other expenses of the Department of Motor Transport during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven.

Out of the Metropolitan Transport Trust General Fund, the sum of Two millions one hundred and ninety-eight thousand three hundred pounds to defray the salaries, maintenance and working expenses and other expenses of the Department of Government Transport during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven.

Out of the Newcastle and District Transport Trust General Fund, the sum of Two hundred and fifty-three thousand four hundred pounds to defray the salaries, maintenance and working expenses and other expenses of the Department of Government Transport during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven.

Out of the Sydney Harbour Trust Fund, the sum of Three hundred and seventy-six thousand three hundred pounds to defray the salaries, maintenance and working expenses and other expenses of the Maritime Services Board of New South Wales during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven.

Out of the Sydney Harbour Trust Renewals Fund, the sum of One hundred and sixteen thousand six hundred pounds to defray the salaries, maintenance and working expenses and other expenses of the Maritime Services Board of New South

South Wales during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven.

And whereas we desire to make good out of the said Funds the sum so granted to Her Majesty; Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. Out of the Consolidated Revenue Fund of New South Wales there shall and may be issued and applied for or towards making good the Supply so resolved to be granted to Her Majesty, the sum of Sixteen millions seven hundred and seventy-seven thousand pounds to be expended at the rates which are shown on the Estimates for the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven, as laid upon the Table of the House, to defray the expenses of the various Departments and Services of the State during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1956-1957.

2. Out of the Government Railways Fund there shall and may be issued and applied for or towards making good the Supply so resolved to be granted to Her Majesty, the sum of Twelve millions four hundred and thirty-two thousand eight hundred pounds to be expended at the rates which are shown on the Estimates for the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven, as laid upon the Table of the House, to defray the salaries, maintenance and working expenses and other expenses of the Department of Railways during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1956-1957.

3. Out of the Road Transport and Traffic Fund there No. 21, 1956. shall and may be issued and applied for or towards £468,400 making good the Supply so resolved to be granted to ^{may be} Her Majesty, the sum of Four hundred and sixty-eight ^{issued out} thousand four hundred pounds to be expended ^{of the Road} at the ^{Transport} rates which are shown on the Estimates for the financial ^{and Traffic} ^{Fund.} year ending thirtieth day of June, one thousand nine hundred and fifty-seven, as laid upon the Table of the House, to defray the salaries, maintenance and working expenses and other expenses of the Department of Motor Transport during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1956-1957.

4. Out of the Metropolitan Transport Trust General £2,198,300 Fund there shall and may be issued and applied for or ^{may be} issued out towards making good the Supply so resolved to be ^{of the Met-} granted to Her Majesty, the sum of Two millions one ^{ropolitan} hundred and ninety-eight thousand three hundred pounds ^{Transport} Trust to be expended at the rates which are shown on the ^{General} ^{Fund.} Estimates for the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven, as laid upon the Table of the House, to defray the salaries, maintenance and working expenses and other expenses of the Department of Government Transport during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1956-1957.

5. Out of the Newcastle and District Transport Trust £253,400 General Fund there shall and may be issued and ^{may be} issued out applied for or towards making good the Supply so ^{of the} resolved to be granted to Her Majesty, the sum of Two ^{Newcastle} hundred and fifty-three thousand four hundred pounds ^{and District} to be expended at the rates which are shown on the Estimates ^{Transport} for the financial year ending thirtieth day of June, ^{Trust} one thousand nine hundred and fifty-seven, as laid upon ^{General} ^{Fund.} the

Out of the Sydney Harbour Trust Fund there shall and may be issued and applied for or towards making good the Supply so resolved to be granted to Her Majesty, the sum of Three hundred and seventy-six thousand three hundred pounds to be expended at the rates which are shown on the Estimates for the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven, as laid upon the Table of the House, to defray the salaries, maintenance and working expenses and other expenses of the Maritime Services Board of New South Wales during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1956-1957.

7. Out of the Sydney Harbour Trust Renewals Fund there shall and may be issued and applied for or towards making good the Supply so resolved to be granted to Her Majesty, the sum of One hundred and sixteen thousand six hundred pounds to be expended at the rates which are shown on the Estimates for the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven, as laid upon the Table of the House, to defray the salaries, maintenance and working expenses and other expenses of the Maritime Services Board of New South Wales during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifty-seven, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1956-1957.

8. The Treasurer shall issue and pay the said sums **No. 21, 1956.** for the Services aforesaid in such manner and in such ^{Treasurer} proportions as the Governor, by Warrants or Orders in ^{to pay under} writing under his hand, and directed to the said ^{Governor's} Treasurer, shall from time to time order and direct. ^{Warrant} ^{or Order.} And the payments so to be made shall be charged upon and paid out of the Consolidated Revenue Fund, the Government Railways Fund, the Road Transport and Traffic Fund, the Metropolitan Transport Trust General Fund, the Newcastle and District Transport Trust General Fund, the Sydney Harbour Trust Fund, and the Sydney Harbour Trust Renewals Fund, respectively.

9. The Treasurer shall in his accounts from time to ^{Treasurer} time be allowed credit for all sums of money paid by ^{to have} him in pursuance of such Warrants or Orders, and the ^{credit and} receipts of the respective persons to whom the same shall ^{receipts to} ^{discharge} him. be so paid shall be full and valid discharges to the said Treasurer in passing his said accounts for such sums as shall be therein mentioned, and he shall receive credit for the same accordingly.

10. This Act may be cited as the "Supply Act, 1956." **Short title.**
