

GENERAL LOAN ACCOUNT APPROPRIATION ACT.

Act No. 50, 1960.

Elizabeth II, No. 50, 1960. An Act to provide for the appropriation of a certain sum out of the General Loan Account and for the application of that sum for certain Public Works and Services; and for purposes connected therewith. [Assented to, 21st November, 1960.]

Preamble. WHEREAS the Australian Loan Council at its eighty-second meeting held on the twenty-third and twenty-fourth days of June, one thousand nine hundred and sixty, decided in pursuance of Clause 3 (9) of Part I of the Agreement set out in the schedule to the Financial Agreement Act, 1944, that the amount to be borrowed for the loan programmes of the Commonwealth and the States for housing and State works for the financial year ending on the thirtieth day of June, one thousand nine hundred and sixty-one, shall be two hundred and thirty million pounds, and by unanimous decision allocated an amount of sixty million six hundred and ninety-four thousand pounds to the State of New South Wales for public works, BE it enacted therefore by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same as follows:—

Short title. 1. This Act may be cited as the "General Loan Account Appropriation Act, 1960".
