Preamble.

108 **General Loan Account Appropriation Act.**

No. 17, 1965 nine hundred and sixty-six, shall be two hundred and ninety-five million pounds, and by unanimous decision allocated an amount of seventy-six million and seventy-five thousand pounds to the State of New South Wales for public works, BE it enacted therefore by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same as follows:—

Short title **1.** This Act may be cited as the "General Loan Account Appropriation Act, 1965".

Appropriation from General Loan Account. **2.** The sum of ninety-one million one hundred and seventy-two thousand pounds is hereby appropriated from the General Loan Account for the public works and services hereunder set out, and shall, as required, be applied as follows:—
