

SUPPLY ACT.

Act No. 35, 1966.

Elizabeth II, An Act to apply certain sums out of the Consolidated Revenue Fund, the Government Railways Fund, the Government Railways Renewals Fund, the Government Railways Fund—Special Reserve created under section 41B (5) of the Government Railways Act, the Road Transport and Traffic Fund, the Metropolitan Transport Trust General Fund, the Newcastle and District Transport Trust General Fund, the Maritime Services Board Fund and the Maritime Services Board Renewals Fund, towards the services of the Year 1966–1967.

WHEREAS

W HEREAS we Your Majesty's most dutiful and loyal subjects, the Members of the Legislative Assembly of New South Wales in Parliament assembled, have resolved to grant to Your Majesty the sum of One hundred and twelve million eight hundred and twenty-one thousand six hundred dollars, that is to say—

Out of the Consolidated Revenue Fund, the sum of Seventy million seven hundred and seventy thousand eight hundred dollars, being the sum required to defray the expenses of the various Departments and Services of the State during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven.

Out of the Government Railways Fund, the sum of Thirty million three hundred and one thousand one hundred dollars to defray the salaries, maintenance and working expenses and other expenses of the Department of Railways during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven.

Out of the Government Railways Renewals Fund, the sum of One million four hundred and seventy-six thousand six hundred dollars to defray the salaries, maintenance and working expenses and other expenses of the Department of Railways during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven.

Out of the Government Railways Fund—Special Reserve created under section 41B (5) of the Government Railways Act, the sum of One hundred thousand dollars to defray the salaries, maintenance and working expenses and other expenses of the Department of Railways during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven.

Out of the Road Transport and Traffic Fund, the sum of Two million two hundred and ninety thousand dollars to defray the salaries, maintenance and working expenses and other expenses of the Department of Motor Transport during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven.

Out of the Metropolitan Transport Trust General Fund, the sum of Four million three hundred and twenty-six thousand three hundred dollars to defray the salaries, maintenance and working expenses and other expenses of the Department of Government Transport during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven.

Out of the Newcastle and District Transport Trust General Fund, the sum of Four hundred and ninety-three thousand eight hundred dollars to defray the salaries, maintenance and working expenses and other expenses of the Department of Government Transport during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven.

Out of the Maritime Services Board Fund, the sum of Two million one hundred and seventy-five thousand seven hundred dollars to defray the salaries, maintenance and working expenses and other expenses of the Maritime Services Board of New South Wales during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven.

Out of the Maritime Services Board Renewals Fund, the sum of Eight hundred and eighty-seven thousand three hundred dollars to defray the salaries, maintenance and working expenses and other expenses of

of the Maritime Services Board of New South Wales No. 35, 1966 during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven.

And whereas we desire to make good out of the said Funds the sum so granted to Your Majesty : Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. Out of the Consolidated Revenue Fund of New South Wales there shall and may be issued and applied for or towards making good the Supply so resolved to be granted to Her Majesty, the sum of Seventy million seven hundred and seventy thousand eight hundred dollars to be expended at the rates which have been sanctioned for the financial year ended thirtieth day of June, one thousand nine hundred and sixty-six, to defray the expenses of the various Departments and Services of the State during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1966-1967.

Out of the Government Railways Fund there shall and \$30,301,100 may be issued and applied for or towards making good the Supply so resolved to be granted to Her Majesty, the sum of Thirty million three hundred and one thousand one hundred dollars to be expended at the rates which have been sanctioned for the financial year ended thirtieth day of June, one thousand nine hundred and sixty-six, to defray the salaries, maintenance and working expenses and other expenses of the Department of Railways during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1966-1967.

No. 35, 1966 **3.** Out of the Government Railways Renewals Fund there shall and may be issued and applied for or towards making good the Supply so resolved to be granted to Her Majesty, the sum of One million four hundred and seventy-six thousand six hundred dollars to be expended at the rates which have been sanctioned for the financial year ended thirtieth day of June, one thousand nine hundred and sixty-six, to defray the salaries, maintenance and working expenses and other expenses of the Department of Railways during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1966-1967.

Out of the Government Railways Fund—Special Reserve created under section 41B (5) of the Government Railways Act there shall and may be issued and applied for or towards making good the Supply so resolved to be granted to Her Majesty, the sum of One hundred thousand dollars to be expended at the rates which have been sanctioned for the financial year ended thirtieth day of June, one thousand nine hundred and sixty-six, to defray the salaries, maintenance and working expenses and other expenses of the Department of Railways during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1966-1967.

Out of the Road Transport and Traffic Fund there shall and may be issued and applied for or towards making good the Supply so resolved to be granted to Her Majesty, the sum of Two million two hundred and ninety thousand dollars to be expended at the rates which have been sanctioned for the financial year ended thirtieth day of June, one thousand nine hundred and sixty-six, to defray the salaries, maintenance and working expenses and other expenses of the Department of Motor Transport during the months of October and November or following month of the financial year ending thirtieth day of

Out of the Metropolitan Transport Trust General Fund \$4,326,300 there shall and may be issued and applied for or towards making good the Supply so resolved to be granted to Her Majesty, the sum of Four million three hundred and twenty-six thousand three hundred dollars to be expended at the rates which have been sanctioned for the financial year ended thirtieth day of June, one thousand nine hundred and sixty-six, to defray the salaries, maintenance and working expenses and other expenses of the Department of Government Transport during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1966-1967.

7. Out of the Newcastle and District Transport Trust General Fund there shall and may be issued and applied for or towards making good the Supply so resolved to be granted to Her Majesty, the sum of Four hundred and ninety-three thousand eight hundred dollars to be expended at the rates which have been sanctioned for the financial year ended thirtieth day of June, one thousand nine hundred and sixty-six, to defray the salaries, maintenance and working expenses and other expenses of the Department of Government Transport during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1966-1967.

8. Out of the Maritime Services Board Fund there shall \$2,175,700 and may be issued and applied for or towards making good the Supply so resolved to be granted to Her Majesty, the sum of Two million one hundred and seventy-five thousand seven hundred dollars to be expended at the rates which have been sanctioned

Out of the Maritime Services Board Renewals Fund there shall and may be issued and applied for or towards making good the Supply so resolved to be granted to Her Majesty, the sum of Eight hundred and eighty-seven thousand three hundred dollars to be expended at the rates which have been sanctioned for the financial year ended thirtieth day of June, one thousand nine hundred and sixty-six, to defray the salaries, maintenance and working expenses and other expenses of the Maritime Services Board of New South Wales during the months of October and November or following month of the financial year ending thirtieth day of June, one thousand nine hundred and sixty-seven, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1966-1967.

10. The Treasurer shall issue and pay the said sums for the Services aforesaid in such manner and in such proportions as the Governor, by Warrants or Orders in writing under his hand, and directed to the said Treasurer, shall from time to time order and direct. And the payments so to be made shall be charged upon and paid out of the Consolidated Revenue Fund, the Government Railways Fund, the Government Railways Renewals Fund, the Government Railways Fund—Special Reserve created under section 41B (5) of the Government Railways Act, the Road Transport and Traffic Fund, the Metropolitan Transport Trust General Fund, the Newcastle and District Transport Trust General Fund, the Maritime Services Board Fund, and the Maritime Services Board Renewals Fund, respectively.

11. The Treasurer shall in his accounts from time to time No. 35, 1966 be allowed credit for all sums of money paid by him in pursuance of such Warrants or Orders, and the receipts of the respective persons to whom the same shall be so paid shall be full and valid discharges to the said Treasurer in passing his said accounts for such sums as shall be therein mentioned, and he shall receive credit for the same accordingly.

12. This Act may be cited as the "Supply Act, 1966." Short title.
