Act No. 61, 1967.

An Act to reduce the stamp duty on entries made in certain records required to be kept under the Swine Compensation Act, 1928, as amended by subsequent Acts; and for purposes connected therewith. [Assented to, 29th November, 1967.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

2. There shall be charged, levied, collected and paid under and subject to the provisions of the Stamp Duties Act, 1920, as amended by subsequent Acts, upon any instrument specified in the Schedule to this Act the duty specified in the said Schedule for credit of the Swine Compensation Fund established under the Swine Compensation Act, 1928, as amended by subsequent Acts, in lieu of the duty imposed by the Swine Compensation Taxation Act, 1961, as amended by the Decimal Currency Act, 1965.
