An Act to provide for the appropriation of a certain sum out of the General Loan Account and for the application of that sum for certain Public Works and Services; and for purposes connected therewith. [Assented to, 27th November, 1974.]

**BE**

*General Loan Account Appropriation.*

**B**E it enacted by the Queen's Most Excellent Majesty, by No. 78, 1974  
and with the advice and consent of the Legislative  
Council and Legislative Assembly of New South Wales in  
Parliament assembled, and by the authority of the same, as  
follows:—

1. This Act may be cited as the "General Loan Account Short title.  
Appropriation Act, 1974".

2. The sum of four hundred and ninety-seven million Appropria-
