Act No. 36, 1983.

An Act to excise land from certain national parks. [Assented to, 22nd April, 1983.]

National Parks and Wildlife (Adjustment of Areas).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "National Parks and Wildlife (Adjustment of Areas) Act, 1983".

Interpretation.

2. In this Act, "reservation" means—

- (a) a reservation by or under the National Parks and Wildlife Act, 1967 (being a reservation of land deemed to be reserved as a national park under the National Parks and Wildlife Act, 1974); or
- (b) a reservation of land by or under the National Parks and Wildlife Act, 1974 (other than a reservation referred to in paragraph (a)).

Excision of certain areas from national parks.

3. (1) The reservation of land as Bundjalung National Park is, to the extent that that reservation applies to the land described in Schedule 1, revoked.

(2) The reservation of land as Hat Head National Park is, to the extent that that reservation applies to the land described in Schedule 2, revoked.

(3) The reservation of land as Ku-ring-gai Chase National Park is, to the extent that that reservation applies to the land described in Schedule 3, revoked.

(4) The reservation of land as Royal National Park is, to the extent that that reservation applies to the land described in Schedule 4, revoked.

National Parks and Wildlife (Adjustment of Areas).

(5) The reservation of land as Wollemi National Park shall, to the extent that that reservation applies to the land described in Schedule 5, be deemed never to have been effected.

SCHEDULE 1.

(Sec. 3 (1).)

All that piece or parcel of land containing about 2.695 hectares situate in the County of Clarence, Parish of Woombah and being reserved road 20.115 metres wide adjoining the eastern boundary of portions 44-47 and extending from the westerly prolongation of the northern boundary of portion 40 to the easterly prolongation of the northern boundary of portion 47.

SCHEDULE 2.

(Sec. 3 (2).)

All those pieces or parcels of land containing 4 065 square metres situate in the County of Macquarie, Parish of Arakoon and being lots 1-5 in Deposited Plan 256190.

SCHEDULE 3.

(Sec. 3 (3).)

All that piece or parcel of land containing about 1.903 hectares situate in the County of Cumberland, Parish of Broken Bay and being that part of lot 79 in Deposited Plan 218269 which lies within the boundaries of Ku-ring-gai Chase National Park.

SCHEDULE 4.

(Sec. 3 (4).)

All those pieces or parcels of land containing about 13 hectares situate in the County of Cumberland, Parish of Wattamolla and being lots 48 and 49 in Deposited Plan 45736.

SCHEDULE 5.

(Sec. 3 (5).)

All that piece or parcel of land containing about 13.54 hectares situate in the County of Hunter, Parish of Blackwater and being lot 34 in Deposited Plan 44393 and also being reserved road 20 metres wide within that lot.
