Pursuant to sec. 23 (5) of the Interpretation Act 1987, the proclamation does not fail merely because it was not published until after the day appointed in the proclamation, but sec. 23 (5) provides, in that event, for the Act to commence on the day on which the proclamation was published in the Gazette.
