Explanatory note

The object of this Order is to amend the Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) 2021—

- (a) to make further provision concerning the holding of, and attendance at, small funeral or memorial services, and
- (b) to enable a person to select another nominated visitor for the person's place of residence if the nominated visitor becomes unable to be a nominated visitor, and
- (c) to clarify the extent of certain reasonable excuses involving compassionate reasons or visiting real property and also the meaning of the term *work*.

1 Name of Order

This Order is the *Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) Amendment (No 2) Order 2021.*

2 Commencement

- (1) This Order commences when the Minister signs this Order, except as provided by subclause (2).
- (2) Schedule 1[1] and [3] commence at the beginning of 2 September 2021.

[1] Clause 3.12 Other persons authorised to visit place of residence

Omit clause 3.12(3)(a). Insert instead—

- (a) either of the following applies—
 - (i) no other individual has been a nominated visitor for the person,
 - (ii) the nominated visitor of the person becomes unable to be the person's nominated visitor, and

[2] Clause 3.13 Maximum number of persons—outdoor public gatherings

Insert after clause 3.13(2)(b)(v)—

(vi) a gathering for a small funeral or memorial service.

[3] Clause 4.13 Other persons authorised to visit place of residence

Omit clause 4.13(3)(a). Insert instead—

- (a) either of the following applies—
 - (i) no other individual has been a nominated visitor for the person,
 - (ii) the nominated visitor of the person becomes unable to be the person's nominated visitor, and

[4] Clause 4.14 Maximum number of persons—outdoor public gatherings

Insert after clause 4.14(2)(b)(v)—

(vi) a gathering for a small funeral or memorial service.

[5] Schedule 2 Reasonable excuses

Omit clause 7. Insert instead—

7 Compassionate grounds

A person may leave the person's place of residence—

- (a) for compassionate reasons, or
- (b) to accompany another person, whom the person is visiting for compassionate reasons, when the other person is undertaking exercise or outdoor recreation authorised by this Order.

[6] Schedule 2, clause 14, heading

Insert "or inspecting property" after "home".

[7] Schedule 2, clause 14(b) and (c)

Omit clause 14(b). Insert instead—

- (b) inspect real property, or
- (c) move between places of residence of the person.

[8] Schedule 4 Dictionary

Omit the definition of work. Insert instead—

work includes work done as a volunteer or for a charitable organisation.
