Explanatory note

The objects of this Order are—

- (a) to require a person in the general area, who has been in a stay at home area or an area of concern in the previous 14 days, to wear a fitted face covering when—
 - (i) in an outdoor area other than a place of residence, or
 - (ii) in an indoor area on common property for residential premises, and
- (b) to remove the 5 worker limit for certain work being carried out in an outdoor area at a place of residence in a stay at home area or an area of concern, and
- (c) to remove the local government areas of Narromine and City of Orange from the regional NSW stay at home area, and
- (d) to retain the local government area of Hilltops in the regional NSW stay at home area, and
- (e) to update the approved COVID-19 safety checklist for swimming pools in stay at home areas or areas of concern, and
- (f) to remove spent provisions.

1 Name of Order

This Order is the *Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) Amendment (No 16) Order 2021*.

2 Commencement

This Order commences as follows—

- (a) for Schedule 1[2] and [4]—at the beginning of 27 September 2021,
- (b) for Schedule 1[5]—at the beginning of 25 September 2021,
- (c) for Schedule 1[6]—at the beginning of 24 September 2021,
- (d) otherwise—on the making of this Order.

Schedule 1 Amendment of Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) 2021

[1] Clause 2.7 Fitted face coverings

Insert after clause 2.7(1)(a)—

- (a1) if the person has been in a stay at home area or an area of concern during the previous 14 days—
 - (i) in an outdoor area other than a place of residence, or
 - (ii) in an indoor area on common property for residential premises, or

[2] Clause 3.11 Workers authorised to visit place of residence

Omit clause 3.11(2)(b). Insert instead—

- (b) the prescribed work is carried out in an outdoor area of the place of residence, or

[3] Clauses 4.3(3B) and (3C) and 4.24(3A) and (3B)

Omit the subclauses.

[4] Clause 4.12 Workers authorised to visit place of residence

Omit clause 4.12(2)(b). Insert instead—

- (b) the prescribed work is carried out in an outdoor area of the place of residence.

[5] Schedule 1 Categories of area

Omit “Narromine,” from clause 3, table, item 1.

[6] Schedule 1, clause 3, table, item 1

Omit “City of Orange,”.

[7] Schedule 1, clause 3, table, items 3 and 4

Omit the items.

[8] Schedule 1, clause 3, table, item 5

Omit “24 September 2021”. Insert instead “1 October 2021”.
