MEAT INDUSTRY ACT 1978 - REGULATION

Commencement

- 1.** This Regulation commences on 1 September 1990.

Amendments

- 2.** The Meat Industry (Licensing) Regulation 1980 is amended:
 - (a) by omitting from clause 6 (1) (i) (i) the matter "\$1,300" and by inserting instead the matter "\$1,400";
 - (b) by omitting from clause 6 (1) (i) (ii) the matter "\$650" and by inserting instead the matter "\$725";
 - (c) by omitting from clauses 20 (2) (c) and 23 (2) (c) the matter "\$125" wherever occurring and by inserting instead the matter "\$137";
 - (d) by omitting from clause 28 (2) (c) (i) the matter "\$250" and by inserting instead the matter "\$262";
 - (e) by omitting from clause 28 (2) (c) (ii) the matter "\$150" and by inserting instead the matter "\$165";

- (f) by omitting from clauses 32 (c) and 39C (c) the matter "\$25" wherever occurring and by inserting instead the matter "\$30";
- (g) by omitting from clause 34C (1) (i) the matter "\$225" and by inserting instead the matter "\$300";
- (h) by omitting from clause 38 (2) (c) (i) and (iii) the matter "\$75" wherever occurring and by inserting instead the matter "\$82";
- (i) by omitting from clause 38 (c) (ii) the matter "\$125" and by inserting instead the matter "\$137";
- (j) by omitting from clause 41 (1) (a) the matter "\$2,600" and by inserting instead the matter "\$2,800";
- (k) by omitting from clause 41 (1) (b) the matter "\$1,300" and by inserting instead the matter "\$1,450";
- (l) by omitting from clause 42 (a) the matter "\$550" and by inserting instead the matter "\$600";
- (m) by omitting from clause 42 (b) the matter "\$50" and by inserting instead the matter "\$60";
- (n) by omitting from clause 42 (c) and (e) (ii) the matter "\$250" wherever occurring and by inserting instead the matter "\$275";
- (o) by omitting from clause 42 (d) (i) the matter "\$500" and by inserting instead the matter "\$525";
- (p) by omitting from clause 42 (d) (ii) the matter "\$300" and by inserting instead the matter "\$330";
- (q) by omitting from clause 42 (e) (i) and (iii) the matter "\$150" wherever occurring and by inserting instead the matter "\$165".

EXPLANATORY NOTE

The object of this Regulation is to increase licence fees payable for the purposes of the Meat Industry Act 1978 so that they will more closely represent the costs of inspection and other services relating to the administration of that Act.
