**Commencement**

**1.** This Regulation commences on 30 September 1992.

**Amendments**

**2.** The Therapeutic Goods and Cosmetics Regulations are amended:

- (a) by omitting from Regulations 15 (1) (c) and 17 (1) (c) the matter “\$250” wherever occurring and by inserting instead the matter “\$270”;
- (b) by omitting from Regulations 15 (2) and 17 (2) the matter “\$35” wherever occurring and by inserting instead the matter “\$40”.

**EXPLANATORY NOTE**

The object of this Regulation is to amend the Therapeutic Goods and Cosmetics Regulations:

- (a) to increase the application and licence fees payable by applicants or holders of licences who are not public institutions in respect of licences authorising the sale by wholesale of certain therapeutic substances; and
- (b) to increase the application and licence fees for public institutions generally.
