

## JUSTICES ACT 1902—REGULATION

(Relating to short descriptions of certain offences under the Traffic Act 1909  
and the Roads (General) Transitional Regulation 1993)

### Commencement

1. This Regulation commences on 1 August 1993.

### Amendments

2. The Justices (Short Descriptions of Motor Traffic and Other Offences) Regulation 1986 is amended:

- (a) by omitting from Schedule 1 the matter relating to the Local Government Act 1993;
- (b) by inserting in Schedule 1 in appropriate order in the matter relating to the Roads (General) Transitional Regulation 1993 the following matter:

**EXPLANATORY NOTE**

The object of this Regulation is to prescribe the short descriptions that, by virtue of section 145B of the Justices Act 1902, are sufficient to state or describe, in any information, complaint, summons, warrant, notice, order or other document, certain offences under the Traffic Act 1909 and the Roads (General) Transitional Regulation 1993.

The Regulation also omits short descriptions relating to certain offences under the Local Government Act 1993 as these have been prescribed in the Justices (Short Descriptions of Local Government Offences) Regulation 1993.
