The Maritime Services Board of New South Wales, in pursuance of the Maritime Services Act 1935, hereby makes the following Regulation:

**Commencement**

**1.** This Regulation commences on 30 June 1995.

**Amendment**

**2.** The Water Traffic Regulations—N.S.W. are amended by omitting from the Regulation specified in Column 1 of the Schedule to this clause the matter specified opposite that Regulation in Column 2 of that Schedule and by inserting instead the matter specified opposite that Regulation in Column 3 of that Schedule.

**EXPLANATORY NOTE**

The object of this Regulation is to increase:

- (a) certain fees for an aquatic licence; and
- (b) the fee for the registration of a registrable vessel; and
- (c) the fee for the recording of the acquisition of the control of a registrable vessel;  
and
- (d) the fee for the issue of a duplicate certificate of registration or a duplicate  
registration plate in relation to a registrable vessel; and
- (e) the fee for the issue, renewal or replacement of trade plates; and
- (f) certain fees for a general, general young adult or commercial licence to  
navigate at speed, including the fee for the issue of a duplicate licence,

payable to the Maritime Services Board as set out in the Water Traffic Regulations—  
N.S.W.

This Regulation is made under the Maritime Services Act 1935, including section 38  
(the general regulation-making power, in particular, section 38 (2) (fi) and (3) (b)).
