**EXPLANATORY NOTE**

The object of this Regulation is to increase certain penalties imposed by penalty notices issued under section 243 of the Roads Act 1993 for contraventions of certain provisions under the Roads (General) Regulation 1994.

This Regulation is made under the Roads Act 1993, including section 264 (the general regulation making power).
