

**TRAFFIC ACT 1909—REGULATION**

(Relating to fees and charges)

**Commencement**

1. This Regulation commences on 1 July 1995.

**Amendments**

**Books of inspection reports**

92AE. The fee for the issue by the Authority to the holder of a proprietor’s authority of a book of inspection reports is the appropriate fee prescribed in Schedule A.
