Explanatory note

The objects of this Regulation are:

- (a) to increase certain fees payable under the *Business Names Act 1962*, and
- (b) to introduce new fees for the lodgment of a Statement of Change in Certain Particulars and a Statement of Change in Persons.

This Regulation is made under the Business Names Act 1962, including section 32 (the general regulation-making power) and the sections referred to in the schedule of fees set out in Schedule 1 to this Regulation.
