# **Liquor Amendment (Application of Registered Clubs Act) Regulation 1997**

under the  
Liquor Act 1982

## **Explanatory note**

Section 182A of the *Liquor Act 1982* provides that the provisions of the *Registered Clubs Act 1976* relating to poker machines apply to and in respect of hotels in the same way as they apply to registered clubs. The application of those provisions is effected by specifying in the *Liquor Regulation 1996*, with appropriate modifications, the provisions of the *Registered Clubs Act 1976* that are to apply (ie the applied provisions).

The *Registered Clubs and Liquor Legislation Amendment Act 1997* contains amendments to the *Registered Clubs Act 1976* relating to the protection of the sensitive areas of poker machines and the temporary removal of compliance plates by licensed technicians. The object of this Regulation is to pick up those changes for the purposes of the applied provisions.

This Regulation is made under the *Liquor Act 1982*, including section 182A and section 156 (the general regulation making power).

**Liquor Amendment (Application of Registered Clubs Act) Regulation 1997**

**1 Name of Regulation**

This Regulation is the Liquor Amendment (*Application of Registered Clubs*) Regulation 1997.

**2 Commencement**

This Regulation commences on 1 September 1997.

**3 Amendment of Liquor Regulation 1996**

The *Liquor Regulation 1996* is amended as set out in Schedule 1.

**4 Notes**

The explanatory note does not form part of this Regulation.

## **Schedule 1 Amendments**

(Clause 3)

### **[1] Schedule 5 The applied provisions**

Insert after section 82D (1):

(1A) A specially authorised person must, if the person breaks any seal in doing anything referred to in subsection (1), replace the seal.

Maximum penalty: 100 penalty units.

### **[2] Schedule 5, section 82D (2)**

Omit “A person”.

Insert instead “Except as provided by subsection (2A), a person”.

### **[3] Schedule 5, section 82D (2A)**

Insert after section 82D (2):

(2A) Subsection (2) does not prevent the holder of a technician’s licence from doing any of the following things in relation to the compliance plate on a poker machine, so long as the machine is not operated at any time when the compliance plate is not attached to the machine:

- (a) moving the compliance plate to another part of the machine,
- (b) removing the compliance plate if it is damaged, and replacing it with a new compliance plate,
- (c) destroying any such damaged compliance plate,
- (d) temporarily removing the compliance plate in order to enable work to be done to the facade of the machine.

Insert before the definition of *computer cabinet*:

*compliance plate* has the same meaning as in section 116D.
