Explanatory note

The object of this Order is to amend the *Totalizer (Distribution of Commission—Racecourse Totalizers) Order 1996* to describe the money to be distributed as various types of commission in terms of proportions of total commission rather than, as at present, in terms of percentages of investments. The amendment does not affect the amounts of commission to be paid or the distribution of those amounts.
