# **Business Names Amendment (Short Descriptions of Offences) Regulation 1998**

under the

**Business Names Act 1962**

## **Explanatory note**

The object of this Regulation is to specify, in accordance with section 145B of the *Justices Act 1902*, the short descriptions of certain offences under the *Business Names Act 1962* (being offences that are currently dealt with by way of a penalty notice).

This Regulation is made under the *Business Names Act 1962*, including section 32 (the general regulation-making power) and in accordance with section 145B of the *Justices Act 1902*.

This Regulation is made in connection with the staged repeal of subordinate legislation under the *Subordinate Legislation Act 1989*.

## **Business Names Amendment (Short Descriptions of Offences) Regulation 1998**

### **1 Name of Regulation**

This Regulation is the *Business Names Amendment (Short Descriptions of Offences) Regulation 1998*.

### **2 Commencement**

This Regulation commences on 1 September 1998.

### **3 Amendment of Business Names Regulation 1995**

The *Business Names Regulation 1995* is amended as set out in Schedule 1.

### **4 Notes**

The explanatory note does not form part of this Regulation.

## Schedule 1 Amendments

(Clause 3)

### [1] Clause 6 Penalty notice offences

Omit clause 6 (a). Insert instead:

- (a) an offence under a provision of the Act specified in Column 1 of Schedule 1 is a prescribed offence, and

### [2] Clause 6 (b)

Insert “Column 3 of” after “specified in”.

### [3] Clause 6A

Insert after clause 6:

#### 6A Short descriptions of offences

- (1) For the purposes of section 145B of the *Justices Act 1902*, the prescribed expression for an offence created by a provision of the Act specified in Column 1 of Schedule 1 is:
  - (a) the expression specified in Column 2 of that Schedule, or
  - (b) if a choice of words is indicated in that expression, the words remaining after the omission of the words irrelevant to the offence.
- (2) For the purposes of any proceedings for an offence created by a provision of the Act specified in Column 1 of Schedule 1, the prescribed expression for the offence is taken to relate to the offence created by the provision, as the provision was in force when the offence is alleged to have been committed.
- (3) The amendment or repeal of a prescribed expression does not affect the validity of any information, complaint, summons, warrant, notice, order or other document in which the expression is used.
