# **Industrial Relations (General) Amendment (Fees and Penalties Imposed by Penalty Notices) Regulation 1998**

## **Explanatory note**

The objects of this Regulation are:

- (a) to increase certain fees set out in Schedule 1 to the *Industrial Relations (General) Regulations 1996* to be paid in respect of the business of the Industrial Relations Commission. and
- (b) to increase certain penalties imposed by penalty notices. issued under section 396 of the *Industrial Relations Act 1996* for contravention of certain provisions of that Act. as set out in Schedule 2 to that Regulation.

This Regulation is made under the *Industrial Relations Act 1996*, including sections 183 (Regulations relating to fees), 396 (Penalty notices) and 407 (the general regulation-making power).

### **1 Name of Regulation**

This Regulation is the *Industrial Relations (General) Amendment (Fees and Penalties Imposed by Penalty Notices) Regulation 1998*.

### **2 Commencement**

This Regulation commences on 1 November 1998.
