Explanatory note

The object of this Regulation is to amend the *Police Service Regulation 1990* to prescribe the capitalisation factors by reference to which the special risk benefit payable in relation to a police officer under section 216 of the *Police Service Act 1990* is to be calculated.

The Regulation is made under sections 216 (2A) and 219 of the *Police Service Act 1990*. Section 216 (2A) was inserted by the *Police Service Amendment (Special Risk Benefit) Act 1998*.
