His Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Private Hospitals and Day Procedure Centres Act 1988*.

Explanatory note

The object of this Regulation is to amend the *Private Hospitals Regulation 1996* and the *Day Procedure Centres Regulation 1996* so as to increase the following fees:

- (a) application fees for licences for private hospitals and day procedure centres,
- (b) application fees for the transfer of licences for private hospitals and day procedure centres.
- (c) annual licence fees for private hospitals and day procedure centres.

This Regulation is made under the *Private Hospitals and Day Procedure Centres Act 1988*, sections 8 (Application for licence), 17 (Annual licence fees), 18 (Transfer of licence to another licensee) and 55 (the general regulation-making power).

Private Hospitals and Day Procedure Centres Amendment (Fees) Regulation 1998

1 Name of Regulation

This Regulation is the *Private Hospitals and Day Procedure Centres Amendment (Fees) Regulation 1998*.

2 Amendment of Private Hospitals Regulation 1996

The *Private Hospitals Regulation 1996* is amended as set out in Schedule 1.

3 Amendment of Day Procedure Centres Regulation 1996

The *Day Procedure Centres Regulation 1996* is amended as set out in Schedule 2.
