

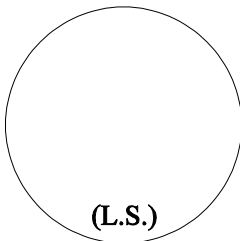


Public Sector Management Act 1988—Proclamation
