# Occupational Health and Safety (Pest Control) Amendment Regulation 1999

under the

Occupational Health and Safety Act 1983

His Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Occupational Health and Safety Act 1983*.

## Explanatory note

The objects of this Regulation are:

- (a) to repeal the requirement for a person who carries on the business of a pest controller to hold a certificate of registration in respect of that business, and
- (b) to repeal ancillary provisions relating to such matters as applications for certificates of registration, determination and refusal of applications, duration, renewal, conditions, cancellation, suspension and production of certificates of registration, and display of registration numbers, and
- (c) to make other minor and ancillary amendments and amendments by way of statute law revision.

This Regulation is made under the *Occupational Health and Safety Act 1983*, including section 45 (the general regulation-making power).

**1    Name of Regulation**

This Regulation is the *Occupational Health and Safety (Pest Control) Amendment Regulation 1999*.

**2    Commencement**

This Regulation commences on 8 December 1999.

**3    Amendment of Occupational Health and Safety (Pest Control)  
Regulation 1988**

The *Occupational Health and Safety (Pest Control) Regulation 1988* is amended as set out in Schedule 1.

Omit “certificate of registration,” wherever occurring in clause 21 (1) and (3).

Omit “certificate of registration,” wherever occurring in clause 23 (1) and (2).

Omit “certificate,”.

**[19] Clause 24 Conditions**

Omit “certificate of registration,” wherever occurring in clause 24 (1), (2) and (3).

**[20] Clause 25 Cancellation or suspension of licence or permit**

Omit “certificate of registration,” from clause 25 (1).

**[21] Clause 25 (1)–(3)**

Omit “certificate,” wherever occurring.

**[22] Clause 26 Appeals**

Omit “certificate of registration,” wherever occurring in clause 26 (1), (2) and (7).

**[23] Clause 26 (1) and (2)**

Omit “certificate,” wherever occurring.

**[24] Clause 28 False information**

Omit “certificate of registration,”.

**[25] Clause 29 Display of signs**

Omit clause 29 (1). Insert instead:

- (1) A pest control operator must display, on the exterior of any vehicle used in connection with the work of destroying or controlling pests, the name of the pest control operator or the name under which the pest control operator carries on the pest control business.

Maximum penalty: \$1,000.

**[26] Clause 31 Powers of inspectors**

Omit “certificate of registration,” from clause 31 (1).

**[27] Clause 31 (1)**

Omit “certificate,”.

**[28] Clause 31 (1A)**

Omit the subclause.
