Act No. 1, 1933.

An Act to provide for the holding of a referendum upon a Bill intituled "A Bill to reform the constitution and alter the powers of the Legislative Council; to reduce and limit the number of Members of the Legislative Council; to reconstitute the Legislative Council in accordance with the reformed constitution; to amend the Constitution Act, 1902, and certain other Acts, and for purposes connected therewith"; to amend the Constitution Further Amendment (Referendum) Act, 1930; and for purposes connected therewith. [Assented to, 1st February, 1933.]

**B**E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**1.** This Act may be cited as the "Constitution Further Amendment (Referendum) Act, 1932." Short title.

**2.** The Bill intituled "An Act to reform the constitution and alter the powers of the Legislative Council; to reduce and limit the number of Members of the Legislative Council; to reconstitute the Legislative Council in accordance with the reformed constitution; to amend the Constitution Act, 1902, and certain other Acts; and for purposes connected therewith," as finally passed through both Houses of the Legislature upon the sixteenth day of December, one thousand nine hundred and thirty-two, shall

**No. 1, 1933.** shall be submitted by way of referendum to the electors qualified to vote for the election of members of the Legislative Assembly.

The thirteenth day of May, one thousand nine hundred and thirty-three, is hereby appointed as the date upon which the votes of the electors at such referendum shall be taken.

The referendum shall be conducted in accordance with the provisions of Part III of the Constitution Further Amendment (Referendum) Act, 1930, as amended by this Act.

**3.** The Constitution Further Amendment (Referendum) Act, 1930, is amended—
