An Act to make further provision with regard to George vi. the allowances to members of the Legislative No. 18, 1938. Assembly, and the salaries of Ministers of the Crown and of certain other persons; to amend the Constitution Act, 1902, and certain other Acts; to repeal the Parliamentary Allowances and Salaries Act, 1932, and for purposes connected therewith. BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the "Parliamentary Short title Allowances and Salaries Act, 1938."

(3) This Act shall be deemed to have commenced upon the first day of July, one thousand nine hundred and thirty-eight.

2. The Principal Act is amended—

- (a) by omitting from section twenty-eight the words "six hundred and seventy pounds" and by inserting in lieu thereof the words "eight hundred and seventy-five pounds";
- (b) by omitting from the same section the words "one hundred and seventy-six pounds" and by inserting in lieu thereof the words "two hundred and fifty pounds."

3. The Principal Act is further amended—

- (a) by omitting from subsection one of section fortyone the words "twenty-one thousand seven hundred and ninety pounds" and by inserting in lieu thereof the words "twenty-two thousand three hundred and forty-five pounds";
- (b) (i) by omitting from the Third Schedule the figures "1,390 0 0" and by inserting in lieu thereof the figures "1,945 0 0";
 - (ii) by omitting from the same Schedule the figures "13,740 0 0" and by inserting in lieu thereof the figures "14,295 0 0."
