

PARLIAMENTARY ALLOWANCES AND SALARIES ACT.

An Act to make further provision with regard to the allowances to Members of the Legislative Council and Legislative Assembly, and the salaries of Ministers of the Crown and of certain other persons; to amend the Constitution Act, 1902, the Parliamentary Allowances and Salaries Act, 1947, and certain other Acts; and for purposes connected therewith. [Assented to, 28th December, 1951.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the "Parliamentary Allowances and Salaries Act, 1951".

(2) The Constitution Act, 1902, as amended by subsequent Acts, is in this Act referred to as the Principal Act.

The Member of the Legislative Council who is for the time being recognised as the principal representative of those members of the Legislative Council who are not supporters of the Government shall be entitled to receive an additional allowance at the rate of five hundred pounds per annum”;

- (b) (i) by omitting from section twenty-eight the words “one thousand three hundred and seventy-five pounds” and by inserting in lieu thereof the words “one thousand eight hundred and seventy-five pounds”;
