

SWINE COMPENSATION (AMENDMENT) ACT.

Act No. 17, 1958.

Elizabeth II, An Act relating to swine duty stamps; for this and
No. 17, 1958. other purposes to amend the Swine Compensation Act, 1928-1935; and for purposes connected therewith. [Assented to, 11th April, 1958.]

BE

BE it enacted by the Queen's Most Excellent Majesty, by **No. 17, 1958.** and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the "Swine Compensation (Amendment) Act, 1958." Short title, citation and commencement.

(2) The Swine Compensation Act, 1928, as amended by subsequent Acts and by this Act, may be cited as the Swine Compensation Act, 1928-1958.

(3) This Act shall commence upon the day upon which the Swine Compensation Taxation Act, 1958, commences.

2. The Swine Compensation Act, 1928-1935, is amended— Amendment of Act No. 36, 1928.

(a) by inserting in subparagraph (i) of paragraph (c) of subsection four of section eight after the figures "1935" the words ", or any other Act imposing a stamp duty upon any entry made in the records required to be made and kept pursuant to the provisions of this Act"; Sec. 8. (Application for compensation, &c.)

(b) (i) by inserting in paragraph (a) of subsection two of section twelve after the figures "1935" the words ", or any other Act imposing a stamp duty upon any entry made in the records required to be made and kept pursuant to the provisions of this Act"; Sec. 12. (Establishment of Fund.)

(ii) by inserting in paragraph (b) of the same subsection after the figures "1935" the words ", or any other Act imposing a stamp duty upon any entry made in the records required to be made and kept pursuant to the provisions of this Act";

(c) by inserting in subsection two of section thirteen after the figures "1935" the words ", or any other Act imposing a stamp duty upon any entry made in such record"; Sec. 13. (Record to be kept at abattoir.)
