# PARLIAMENTARY ALLOWANCES AND SALARIES (AMENDMENT) ACT. 



Act No. 41, 1969.
An Act to make further provisions with regard to the salaries and allowances of Members of the Legislative Council and Legislative Assembly, Ministers of the Crown and the holders of certain other offices; to amend the Constitution Act, 1902, the Parliamentary Allowances and Salaries Act, 1956, and certain other Acts; and for purposes connected therewith. [Assented to, 17th April, 1969.]

Parliamentary Allowances and Salaries (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by No. 41, 1969 and with the advice and consent of the Legislative
Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:-

(2) This Act shall commence on the first day of July, one thousand nine hundred and sixty-nine.
