Act No. 63, 1976.

An Act to promote the revision of the statute law by repealing enactments which have ceased to be in force or have become unnecessary. [Assented to, 2nd November, 1976.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled. and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Statute Law Revision Act, 1976".

Repeal.

2. Each Act specified in Schedule 1 is, to the extent therein expressed, repealed.

Saving.

3. (1) The repeal by this Act of any enactment does not—

Act No. 35, 1937, s. 4 (1) (a), (g).

- (a) revive anything not in force or existing at the time at which the repeal takes effect; or
- (b) affect the proof of any past act or thing.

Act No. 35, (2) This section does not limit any saving in the 1937, s. 4 Interpretation Act, 1897.
