Act No. 169, 1980.

An Act to amend the Valuation of Land Act, 1916, to deem "land values" determined under that Act to be "land values" for the purposes of certain other Acts, and for other purposes. [Assented to, 15th December, 1980.]

Valuation of Land (Water Boards) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

- 1. This Act may be cited as the "Valuation of Land Short title. (Water Boards) Amendment Act, 1980".
- 2. (1) Except as provided in subsection (2), this Act shall Commence-commence on the date of assent to this Act.
