Act No. 88, 1989

An Act to amend the Simon University College Act 1988 so as to reconstitute the Australian William E. Simon University College as a university; and for other purposes. [Assented to 13 June 1989]

The Legislature of New South Wales enacts:

Short title

1. This Act may be cited as the Simon University College (Amendment) Act 1989.

Commencement

2. This Act commences on a day to be appointed by proclamation.

Amendment of Simon University College Act 1988 No. 89

3. The Simon University College Act 1988 is amended as set out in Schedule 1.

Saving

4. On and from the commencement of this Act, anything done by or in the name of the Australian William E. Simon University College before that commencement is to be taken to have been done by or in the name of the Australian William E. Simon University.

(5) Section 5-

Omit the section, insert instead:

Authorisation

5. The Australian William E. Simon University is a university and is authorised to be called a university.

(6) Section 7-

Omit the section, insert instead:

Degrees

7. (1) The University is authorised to confer degrees on its own behalf, but the nomenclature of any such degrees is to be as approved by the Secretary of the Ministry of Education and Youth Affairs.

(2) The University is authorised to confer degrees of or on behalf of the University of Rochester School of Business Administration, but only with the approval of the School.

(3) The University is authorised to confer degrees of or on behalf of any other corporation, body or institution, but only with the approval of the corporation, body or institution and the approval of the Secretary of the Ministry of Education and Youth Affairs.
