Act No. 97, 1992

An Act to amend the Endangered Fauna (Interim Protection) Act 1991 with respect to the operation of certain provisions of that Act; and to extend the duration of certain licences under the National Parks and Wildlife Act 1974. [Assented to 2 December 1992]

Endangered Fauna (Interim Protection) Amendment Act 1992 No. 97

The Legislature of New South Wales enacts:

Short title

1. This Act may be cited as the Endangered Fauna (Interim Protection) Amendment Act 1992.

Commencement

2. This Act commences, or is taken to have commenced, on 30 November 1992.

Amendment of Endangered Fauna (Interim Protection) Act 1991 No. 66, s. 7 (Repeals)

3. The Endangered Fauna (Interim Protection) Act 1991 is amended:
- (a) by omitting from section 7 wherever occurring the matter “1 December 1992” and by inserting instead the matter “1 October 1993”;
 - (b) by inserting in section 7 (2) after the words “The provisions inserted in the Environmental Planning and Assessment Act 1979 by Schedule 2” the words “(as amended by section 13 of the Timber Industry (Interim Protection) Act 1992)”.

Extension of certain licences under National Parks and Wildlife Act 1974

4. (1) This section applies to a general licence issued under section 120 of the National Parks and Wildlife Act 1974 to take or kill endangered fauna, being a licence which:

- (a) was issued after the commencement of the Endangered Fauna (Interim Protection) Act 1991 on 17 December 1991 and before the publication of the revised Schedule 12 to the National Parks and Wildlife Act 1974 on 28 February 1992; and
- (b) is expressed to expire before 1 October 1993 (either when issued or as a result of a variation of the licence).

This section also applies to any such licence issued after the publication of the revised schedule if the Director notifies the holder of the licence that this section applies to the licence.

(2) A general licence to which this section applies continues in force (despite any expiry date specified in the licence) until 1 October 1993, unless duly cancelled in accordance with the National Parks and Wildlife Act 1974. 1 October 1993 is taken to be specified in the licence as the date of its expiry.

Endangered Fauna (Interim Protection) Amendment Act 1992 No. 97

(3) Any such licence may be varied under section 133 of the National Parks and Wildlife Act 1974.

(4) Expressions used in this section have the same meanings as they have in the National Parks and Wildlife Act 1974.

(5) This section expires on 1 October 1993.
