Act No 11, 1995

An Act to amend certain Acts and to repeal certain other Acts and a regulation as a consequence of the enactment of the *Local Government Act 1993;* and for other purposes. [Assented to 9 June 1995]

The Legislature of New South Wales enacts:

1 Name of Act

This Act is the Statute Law Revision (Local Government) Act 1995.

2 Commencement

- (1) This Act commences on a day or days to be appointed by proclamation, except as provided by this section.
- (2) The amendments to the *Local Government Act 1919* in Schedule 1, and section 3 in its application to those amendments, are taken to have commenced on 1 January 1995.

3 Amendment of Acts

Each Act specified in Schedule 1 is amended as set out in that Schedule.

4 Repeals

Each Act and the instrument specified in Schedule 2 is repealed.
