Act No 73, 2024

An Act to amend the *Road Transport Act 2013* in relation to the average speed of vehicles between detection points; and for related purposes. [Assented to 31 October 2024]

Road Transport Legislation Amendment (Speed Camera Detection) Act 2024 No 73 [NSW]

The Legislature of New South Wales enacts—

1 Name of Act

This Act is the Road Transport Legislation Amendment (Speed Camera Detection) Act 2024.

2 Commencement

This Act commences on the date of assent to this Act.

Schedule 1 Amendment of Road Transport Act 2013 No 18

[1] Section 127 Definitions

Omit "heavy" wherever occurring in the definitions of *detection points*, *journey time* and *shortest practicable distance*.

Insert after section 133—

133A Review of use of division in relation to light vehicles

- (1) The Minister must ensure a review is conducted of the use of this division in relation to light vehicles.
- (2) The review must consider—
 - (a) road safety outcomes from the use of this division in relation to light vehicles, including the following—
 - (i) the number of speeding offences involving light vehicles and the trends in the commission of the offences,
 - (ii) the impact on speeding by drivers of light vehicles,
 - (iii) the average speed of light vehicles,
 - (iv) the estimated impact on crashes and other trauma involving light vehicles, and
 - (b) the cost of using this division in relation to light vehicles.
- (3) The review must be undertaken as soon as possible after the period of 18 months from the commencement of this section.
- (4) A report on the outcome of the review must be tabled in each House of Parliament within 6 months after the end of the period of 18 months.

[9] Section 183 Definitions

Omit "heavy" from section 183(1), definition of *average speed detected offence*.

- [10] Section 191 Application of this Division to average speed detected offences Omit "heavy" wherever occurring.
- [11] Section 193 Liability of actual offender unaffected Omit "heavy" from section 193(3).
