1 Name of plan

This plan is Manly Local Environmental Plan 1988 (Amendment No 55).

2 Aims of plan

This plan aims to amend *Manly Local Environmental Plan 1988* so as to:

- (a) alter the definition of *residential flat building*, and
- (b) introduce a definition of *multi-dwelling development*, and
- (c) update references to the Manly Development Control Plan for the Residential Zone.

3 Land to which plan applies

This plan applies to land within Manly Local Government Area.
