# Auburn Local Environmental Plan 2000 (Amendment No 7)

## 1 Name of plan

This plan is Auburn Local Environmental Plan 2000 (Amendment No 7).

#### 2 Aims of plan

This plan aims:

- (a) to rezone part of the land to which this plan applies from Zone No 6 (a)—Public Recreation Zone to Zone No 2 (c)—Residential (Residential Flat Buildings) Zone under *Auburn Local Environmental Plan 2000*, and
- (b) to reclassify the land to which this plan applies from community land to operational land within the meaning of the *Local Government Act 1993*.

#### 3 Land to which plan applies

- (1) To the extent that this plan rezones land, it applies to Lot 2, DP 959197, being land on the corner of Dartbrook Road and Simpson Street, Auburn, as shown coloured pink on Sheet 1 of the map marked "Auburn Local Environmental Plan 2000 (Amendment No 7)" deposited in the office of Auburn Council (*the amending map*).
- (2) To the extent that this plan reclassifies land, it applies to the following land:
  - (a) Lots 32 and 33, DP 9380 and Lot 57, DP 6713, being land in Chisholm Road, Auburn, Lots 1–3, DP 235351, being land in Chisholm Road East, Auburn, Lot 18, DP 6713, being land in Killeen Street, Auburn, Lots 26, 30 and 31, DP 9380, being land in Ostend Street, Auburn and Lots 7–11 and 35, DP 13471, being land in Weymouth Avenue, Auburn, as shown edged heavy black on Sheet 2 of the amending map,
  - (b) Lot 2, DP 959197, being land on the corner of Dartbrook Road and Simpson Street, Auburn, as shown edged heavy black on Sheet 3 of the amending map,

- (c) Lots 28, 34, 35, 37 and 41, DP 8800, being land in Edgar Street, Auburn, Lot 48, DP 77377, being land in Stanhope Street, Auburn, Lots 14, 16–19, 29–32, 34–36 and 42, DP 1463, being land in Webbs Avenue, Auburn and Lots 5 and 44, DP 7097, being land in West Street, Auburn, as shown edged heavy black on Sheet 4 of the amending map,
- (d) Lot 22, DP 219238, being land in Eric Crescent, Lidcombe, as shown edged heavy black on Sheet 5 of the amending map.
