1 Name of Plan

This Plan is Manly Local Environmental Plan 1988 (Amendment No 80).

2 Commencement

This Plan commences on the day on which it is published on the NSW legislation website.

3 Land to which Plan applies

This Plan applies to all land to which *Manly Local Environmental Plan 1988* applies and, in particular, to the following land:

- (a) Part Lot 22, DP 1124834, 2A Beatty Street, Balgowlah Heights, as shown coloured orange on Sheet 1 of the map marked "Manly Local Environmental Plan 1988 (Amendment No 80)" deposited in the office of Manly Council (*the Map*),
- (b) Lot 312, DP 4889, 16 Edgecliffe Esplanade, Seaforth, as shown edged heavy black on Sheet 2 of the Map,
- (c) Lot 1, DP 252420, 36 Stuart Street, Manly, as shown edged heavy black and hatched on Sheet 3 of the Map,
- (d) Lot 100, DP 1125884, Castle Circuit, Seaforth, as shown edged heavy black and hatched on Sheet 4 of the Map.
