1 Name of Plan

This Plan is *Camden Local Environmental Plan 2010 (Amendment No 5)*.

2 Commencement

This Plan commences on the day on which it is published on the NSW legislation website.

3 Land to which Plan applies

This Plan applies to the following land:

- (a) certain land off Macquarie Grove Road, Kirkham, within the Mater Dei Release Area,
- (b) land in the Spring Farm Urban Release Area, including certain land fronting Macarthur Road and Springs Road, Spring Farm South Village and Spring Farm West Village,
- (c) certain land in Harrington Grove and part of the Harrington Park Homestead property, including 730 Dan Cleary Drive, G Harrington Parkway, 1 Nolan Way, 131, 179A and 187 The Northern Road and 5 Towra Circuit,
- (d) part of the land known as Elyard Gardens, 1 Elyard Street, Narellan.
