1 Name of Plan

This Plan is *Canada Bay Local Environmental Plan 2013 (Amendment No 1)*.

2 Commencement

This Plan applies to land known as the Strathfield Triangle which, immediately before the making of this Plan, was land identified as deferred matter under *Canada Bay Local Environmental Plan 2013*.

Omit “Local roads” wherever occurring in the table to clause 5.1 (2).

Insert instead “Local road”.

[5] Clause 5.1 (2), table

Insert the following after the matter relating to Zone R3 Medium Density Residential under the headings “**Type of land shown on Map**” and “**Authority of the State**”, respectively:
